MASTER OF COMMON LAW (SEPTEMBER 2025 INTAKE)

Applications are invited for admission in September 2025 to read for the degree of Master of Common Law (MCL). The usual duration of the programme is one academic year of full-time study. The application deadlines are:

- Main Round: 12:00 PM (GMT +8) on December 13, 2024 (Friday)
- Clearing Round: 12:00 PM (GMT +8) on February 28, 2025 (Friday)

Admission offers may be made on a rolling basis, and late applications will only be considered if places are still available.

ADMISSION REQUIREMENTS

To be eligible for admission to the courses leading to the Master of Common Law, a candidate:

- (a) shall comply with the <u>General Regulations</u> and the <u>Regulations for Taught Postgraduate Curricula</u>; and
- (b) shall hold the degree of Bachelor of Laws with at least a second-class honours or equivalent qualification in a non-common law jurisdiction; and
- (c) for a candidate who is seeking admission on the basis of a qualification from a university or comparable institution outside Hong Kong of which the language of teaching and/or examination is not English, shall satisfy the University English language requirement applicable to higher degrees as prescribed under General Regulation G2(b).

The Faculty has specific requirements regarding IELTS and TOEFL tests¹:

<u>Test</u> <u>Minimum Requirement(s)</u>

IELTS (Academic) An overall band of 7.0 or above with no subtest below 6.5

TOEFL (Paper-based Test)² A score of 593 or above TOEFL (Internet-based Test)² A score of 97 or above

SCHOLARSHIP OPPORTUNITIES

Scholarships may be awarded to a limited number of qualified students enrolled in the programme. An invitation to apply for the scholarship will be sent to all admitted students after announcing the first semester results, i.e., around February 2026 for the September 2025 intake. Applicants who would like to apply for the scholarship shall submit a separate application by a specific deadline.

In any given year, if candidates are adjudged to be of insufficient merit, no awards shall be made.
