**Master of Arts in the field of Chinese Language and Literature Programme (2025/2026)**

1. Applications are invited for admission in September 2025 to read for the degree of Master of Arts (MA) in the field of Chinese Language and Literature. The curriculum shall normally extend over one academic year of full-time study and two academic years of part-time study. Applications will be considered on a rolling basis. The application deadlines are:

First round: **12:00 noon (GMT +8), January 27, 2025**

Second round: **12:00 noon (GMT +8), April 30, 2025**

### **Admission Requirements**

2. To be eligible for admission to the programme, a candidate shall satisfy both the University Admission Requirements and the Programme Specific Requirements as listed below:
  - (a) shall comply with the [General Regulations](#);
  - (b) shall hold
    - (i) a good Bachelor's degree of this University; or a qualification of equivalent standard from this University or another comparable institution accepted for this purpose; and
    - (ii) a good Bachelor's degree with a major in Chinese or a closely related subject;
  - (c) for a candidate who is seeking admission on the basis of a qualification from a university or comparable institution outside Hong Kong of which the language of teaching and/or examination is not English, shall satisfy the University English language requirement applicable to higher degrees as prescribed under [General Regulation G2\(b\)](#).

The programme has its specific requirements with regard to TOEFL and IELTS:

<u>Test</u>	<u>Minimum requirement</u>
TOEFL: Paper-based test (PBT)	Overall score of 550 with 4 in Test of Written English (TWE); or
TOEFL: Internet-based test (iBT)	Overall score of 80 with 25 in Writing; or
IELTS	Band 7 with no subtest lower than 5.5

Note: Only TOEFL/IELTS scores recorded in the two years before the date of application are considered. IELTS Indicator and TOEFL Special Home Edition are not accepted.

- (d) shall satisfy the examiners in a qualifying examination or an interview if required.
3. An application for exemption from the above requirements shall be considered on a case-by-case basis.

### **Application**

4. Applications for this programme and payment of application fee (HK\$300 per application) should be submitted online at <https://admissions.hku.hk/tpg>.
5. After submitting the online application, applicants are required to upload the supporting documents within one month starting from the date of receipt of the email notification. A checklist of the required supporting documents is available at <https://admissions.hku.hk/tpg/programme-list>.
6. In order to support the University's environmental friendly initiatives, documents uploaded to the system should NOT be delivered to the University by post in duplicate, unless you receive notification to submit your documents.

7. Applicants who do not hear from the Faculty of Arts by August 31, 2025 may assume their applications unsuccessful.

### **Regulations and Syllabuses**

### **Concurrent Studies**

9. General Regulation G6(b)(i) prohibits concurrent registration by a student of this University for any other post-secondary qualification either at this University or at any educational institution, unless approval of the Senate has been obtained in advance. Students in breach of this regulation may be required to discontinue their studies at this University.

### **Visa for Studies**

10. All applicants without the right of abode/right to land in Hong Kong must apply for a student visa for the purpose of education from the Hong Kong Immigration Department (ImmD) registration in our programmes. Normally the student visa is only granted to those admitted to full-time studies. Students are responsible for ensuring that they have a valid visa and register in the programmes before the study begins. If any student fails to register in time, the offer of admission may be withdrawn and all fees already paid will not be refunded.

### **Scholarship**

11. The award of the “MA in the field of Chinese Language and Literature Entrance Scholarship” is based on the academic results in applicant’s undergraduate studies (First Class Honours or CGPA of 3.6 or above [or equivalent]). When those applicants whose academic results meet the said criteria have received offer of admission to the programme, they will be deemed eligible for the award of the Scholarship. Applicants currently in the final year of their undergraduate studies will also be considered for the Scholarship if their final academic results meet the criteria.
