An email notification will be sent to you within 48 hours, please follow the instructions in the email and upload your supporting documents in pdf format for our preliminary consideration by logging in <https://tpg-admission-addon.its.hku.hk/applicant>. All documents should be submitted **within ONE month** starting from the date you receive the email notification.

Transcripts, diplomas, certificates and other submitted documents which are not in English should be accompanied by a certified translation in English. Certified translation may be provided by your home institution. Applications without online supporting documents may not be considered.

Your 10-digit application number should be included on the file name of each document in the following format. For example:
